

SHADOW SINFONIA AFTER-ACTION REPORT

PRIMARY OBJECTIVE: FIND AND CAPTURE NOVAK NAVARR AKA FINGO DEVOSS

OUTCOME: **FAILURE**

OVERVIEW:

Novak Navarr, former member of the "Sultans of Sabacc" and murderer of Buster Gazeeber, must be found and captured. This is a "clean up" mission following our recovery of Professor Tover Rasario.

MISSION HIGHLIGHTS:

- The team gathered some valuable intel on our target:
 - His new alias is Fingo Devoss, and he is a Clawdite (explaining the Bendak look-alike and his ability to repeatedly evade capture)
 - Navarr had a shell corporation, **Face Savers Unlimited** (since dissolved by our operations)
 - The shell corporation was registered through **Free-Flight Dance Dome**, a popular entertainment venue (and underworld gathering place) owned by **Zentoo Mundi**, a well-connected Chagrian
 - His was moving large sealed shipping crates through **Dream Emporium**, a successful warehouse/shopping complex for wealthy consumers owned by **Hakken Dotin**, an unusually grandiose Ithorian
 - The sealed crates being stored at Dream Emporium were all coming from the same place: **Sabodor's Pet Emporium**
 - Turns out, Sabodor (a nasty little Rakririan) was providing large and exotic creatures to Navarr's new project: **The Rumble Pit**.
 - The Rumble Pit was a disgusting gladiator facility for rare animals (Rancor, Ackley, Nexu, many others)
 - Sabodor had an illegal carbonite freezing facility hidden in his pet shop. This was used to facilitate long-term storage and shipment of the large exotic creatures. The Espos have shut it down.
 - The Rumble Pit was also raided and shut down. Not because the CSA cares about exotic animals, but because it wasn't paying its taxes
- If we catch scent of Navar/Devoss again, we shall pursue.
- In spite of this setback to our reputation and information channels, we have not given up on locating Jecksi.

THE CONDUCTOR'S REVIEW:

The Conductor is deeply disappointed that Novak Navarr (AKA Fingo Devoss) was not captured or, failing that, eliminated. The Clawdite proved to be a very slippery target.
